Emergency Preparedness 101: CLEAN Sponsors Free Seminar to Get Back to Basics

More than 60 representatives from businesses in the Kapolei area attended “Emergency Preparedness 101,” a free, all-day seminar on the basics of emergency response planning sponsored by the Campbell Local Emergency Action Network (CLEAN) at the Filipino Community Center on May 14.

The seminar, led by **Paul Dixon** of California-based Dixon Risk Services, provided an overview of the importance of investing in emergency response planning and provided practical planning tools so that participants could develop their own emergency response plans.

“We can never stress the importance of emergency preparedness enough. We have all seen the extent of damage that can be caused by a hurricane or earthquake right here in Hawaii,” said **Annie Lam**, CLEAN president and Tesoro’s supervisor - contingency planning and response. “It is not a matter of ‘if’ but ‘when.’ CLEAN wants to equip organizations so that we can all be ready for the next disaster.”

This year, CLEAN also invited special guests **James Weyman**, director of the Central Pacific Hurricane Center and **Ray Tanabe**, warning coordination meteorologist with the National Weather Service to share about the valuable services they offer for facility emergency

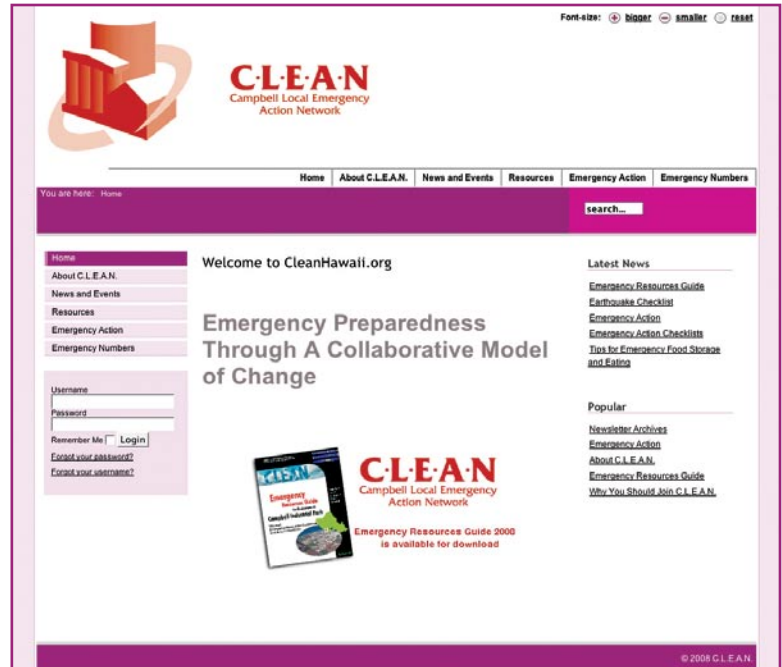
CLEAN Launches Stand-Alone Website with New Look

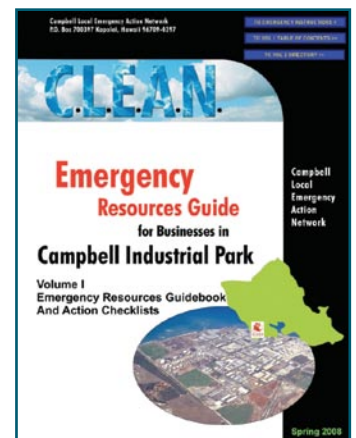
CLEAN has been involved in a number of activities to promote the welfare of the tenants of Campbell Industrial Park (CIP) and the surrounding neighbors. These efforts have included community education programs, emergency response exercises, enhanced emergency warning systems, and of course, the continuing development of the community-based CIP Emergency Resources Guide (ERG).

The ERG is a significant component in an improved management system for emergencies that affect the CIP community. The purpose of the Guide is to improve the effectiveness of existing responses and to improve community alert and emergency notification by providing information about the Park, its residents and specific hazards associated with CIP.

The Guide provides guidance and information to emergency response personnel, local residents, and businesses based on the specific conditions in and around CIP.

Accurate information is of utmost importance. The ERG is a work in progress that is improved, maintained and updated annually to ensure its value to the CIP community.

This year's update of the ERG book was completed by **Paul Dixon**, of Dixon Risk Services, Inc., who was involved in developing the first edition of ERG.

coordinators. The seminar was intentionally held in May, just prior to the hurricane season, which typically starts in June and continues through November.

A number of government officials participated in the seminar as well. **Maeda Timson**, chair of the Makakilo/Kapolei/Honokai Hale neighborhood board, praised CLEAN for its contributions to the community over the past decade; **Rep. Karen Awana** provided an update on pending appropriations for systems to enhance emergency preparedness that were introduced in the past legislative session held earlier this year; and **Sen. ERG: Volumes 2 & 3 Updated



Volumes 2 and 3 of the Guide include updated information that reflect residents leaving or moving into CIP. Chemical inventories and uses may also periodically change and are to be documented in the hazard analysis information provided to the LEPC and local fire department in Volume 3.

Updating the Guide included a survey of CIP businesses and those in the neighboring Kenai Industrial Park and Kapolei Business Park to identify new businesses and to distribute emergency alert radios provided by CLEAN. CDs were produced and relevant websites updated. The City and County’s existing database is also updated through electronic MARPLOT and CAMEO files.

The final package was distributed in May 2008 to all of our CIP communities. Each package included a cover letter from CLEAN and user information and instructions about this year’s edition. The ERG is now uploaded on the CLEAN website www.CLEANHawaii.org. In addition to mailing the final distribution, a link on the Local Emergency Planning Committee’s website points to the ERG on the CLEAN website.

Kalaeloa Boulevard Improvements Begin

Access to and from Campbell Industrial Park will be easier in a couple of years, thanks to a major improvement project now underway. Construction on Kalaeloa Boulevard from H-1 to Malakole Street at Campbell Industrial Park, which began in July, is designed to improve access to the major job center and is expected to be completed in 2010. The improvements include rebuilding and widening Kalaeloa from four to six lanes.

The first phase will involve the intersection of Kalaeloa and Kapolei Parkway, and Kalaeloa Boulevard between the H-1 Palailai Interchange and the railroad tracks going in both directions. This first phase is expected to be completed by spring 2009.
